ADDENDUM A Equestrian Facility Reservation Form

This Addendum shall be used as a Reservation Request Form for use of the Santa Rosa Ranchos Equestrian Facility, subject to the signed Equestrian Facility Assumption of Risk, Release from Liability and Indemnification Agreement hereby incorporated. It is intended for controlling facility usage by groups or organizations charging a fee to participants. It is also to be used for general facilities reservation by residents or Association sponsored classes, events, programs, and community gatherings serving the Santa Rosa Ranchos HOA or Gavilan Springs HOA.

GENERAL INFORMATION

- 1. All reservation requests must be in writing or via e-mail with at least 30 days notice.
- 2. Changes to a confirmed reservation must be made at least 7 days before the reserved date.
- 3. The reservation date and details will be listed on the Santa Rosa Ranchos Equestrian Center master calendar available online at www.calendar.yahoo.com/srranchoseqctr.
- 4. The arena and grounds must be left in the same condition as supplied. All trash and manure must be properly disposed of in the provided receptacles. A \$200 clean-up fee will be charged if left dirty! The arena is in an "as is" condition and carries no guarantees as to suitability for the event.
- 5. If insurance is required, the organization must provide a copy of their insurance naming Santa Rosa Ranchos HOA and Gavilan Springs HOA as additional insureds. The minimum amount of liability is \$1 million. Insurance riders must be received at least 10 days before the requested use date and before final confirmation will be given.
- 6. All Arena & Common Area Use Rules and Regulations must be followed.
- 7. Facilities must be vacated by 10:00 pm weekdays and 11:00pm weekends unless specific arrangements have been approved beforehand.
